In continuation to the Admission Notice for Academic Session 2020-21, the Department of Social Work is making an **OPEN CALL** for admission to the MSW Programme **to fill-up vacant seats** for the academic session 2020-21. In this regard, it is informed to all eligible applicants that the **last date for application** has been **extended** by the university upto **06.12.2020 (Sunday)**. How to Apply

Interested candidates can register themselves for the vacant seats of the MSW Programme by submitting a duly filled **registration form** and paying registration fee on **Samarth Portal** at the live link: <https://cuhimachaladmission.samarth.edu.in/> which shall be active upto 06.12.2020.

In addition to getting registered / applying on the above live link, the applicants / Registered candidates are required to submit self-attested copies of documents (10th, 10+2, Graduation marks sheet, Degrees and category certificate and other testimonials as mentioned in the prospectus) through e-mail at shababahmad@hpcu.ac.in, immediately after completing registration on the above live link.

The following candidates also can register themselves by submitting the online application form & application fees on or before **06.12.2020 (Sunday)**.

1. Candidates who were already in the selection list but failed to submit the fees may also avail this opportunity as a 'Fresh Applicant.'
2. The candidates who could not submit their result of qualifying examination in time and/or need to update marks after reevaluation can also send their result and register.

MINIMUM ELIGIBILITY REQUIREMENT: A minimum of 50% Marks or an equivalent grade in the Bachelors level of a recognized University or an equivalent examination in the specified discipline. **Relaxation in minimum qualifying marks up to a maximum of 5% shall be made in case of candidates belonging to the SC, ST, OBC (Non-creamy layer) and Persons with Disabilities Categories.**

IMPORTANT NOTE:

1. The candidates should ensure they satisfy the above minimum eligibility requirement for admission to MSW Programme. Please refer the Prospectus available in the university website for details (<http://www.cuhimachal.ac.in/news/20200610124053709.pdf>)
2. The **list of the selected candidates** decided **on the basis of Merit** as per the percentage of marks secured by the candidate at the Bachelors level shall be uploaded on the university website at www.cuhimachal.ac.in on **07.12.2020 by 5:00 P.M.**
3. The selected candidates will have to deposit the admission fee latest by **08.12.2020 (11.00 AM)**.
4. **Date of ONLINE VERIFICATION** of certificates/degrees and other testimonials of candidates who have deposited their admission fees shall **start on 08.12.2020 at 12.00 Noon** and shall **close on 08.12.2020 at 4.00 P.M.** ***Verification of all original documents has to be done compulsorily, failing which their admission will be cancelled and they will lose their seat.***
