To place before the Executive Council matter regarding decision taken by the Hon'ble Vice-Chancellor to extend the period of the validity of Employment Notice No. 002/2015 dated 09th May, 2015.

The University has advertised various teaching positions in different disciplines vide Employment Notice No. 002/2015 dated 19.05.2015. The University received applications for various post of Professor, Associate Professor and Assistant Professor in response to the said advertisement and constituted screening committees for screening of applications so received. The screening Committees forwarded their recommendations for the post of Professor, Associate Professor and Assistant Professor. Accordingly the details after screenings were uploaded on the University website for feedback.

In the meanwhile the UGC issued 3^{rd} and 4^{th} amendment to the UGC Regulation 2010.

The University vide letter No. 4-1/CUHP/Estt./2010/Pt. File/2769 dated 31.05.2016 and subsequent reminder No. 4-1/CUHP/Estt./2010/Pt. File/3458-60 dated 06.07.2016 sought clarification from the UGC on the date of eligibility of these (3rd & 4th) amendments. The UGC vide DO letter No. 1-122/2016(VIP/PS) dated 30th August, 2016 clarified as under: -

That the appointments of teachers and other academic staff through direct recruitment shall be governed by the UGC Regulations on Minimum Qualifications for Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of the Standards of Higher Education, 2010 alongwith their Amendments notified at the time of issuance of the advertisements and subject to the following conditions: -

- The University concerned has followed the UGC Regulations on Minimum Qualifications for Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of the Standards of Higher Education, 2010 along with Amendments notified at the time of issuance of the advertisement.
- 2. The advertisement for the post(s) was published before the notification of the subsequent Amendments.
- 3. Due selection criteria/process as prescribed in the Regulations and their Amendments, in operation on the date of advertisement, was followed.
- 4. No modification was made subsequently in the original advertisement.

As per DOPT office Memorandum No. 2(1)/E.Cord(I)/2003 dated 9th September, 2003, if a post remains unfilled for one year or more, its deemed as abolished. Further DOPT OM No. Misc. -14017/15/2012-Estt(RR) dated 11.01.2016 provides that "while initiating the recruitment process to fill vacant post(s) by the method of direct recruitment, it may be ensured that the entire recruitment process including and starting from advertisement, conducting written examination or holding of interview may be completed within six months.

The life of advertisement No. 002/2015 dated 19^{th} May, 2015 expired on 22^{nd} June, 2016. However, given the advanced stage of screening, critical gaps in faculty capability and the instructions from MHRD to expeditiously fill up posts, the Vice-Chancellor vide his orders dated 26.09.2016 has extended the currency period of the Employment Notice 002/2015 for a further period of six months i.e. upto 22^{nd} December, 2016 so as to fill up the posts.

The Executive Council noted and ratified the decision taken by the Vice-Chancellor.

With regard to Annual Accounts 2015-16, it is submitted that due to non-receipt of final report from CAG Delhi the Audited Annual Accounts alongwith Separate Audit Report (SAR) could not be reported to the Executive Council and as such the Audited Annual Accounts for the year 2015-16 cannot be sent to MHRD as on date. Therefore, it is also proposed to seek approval of the Executive Council to permit the University to submit the Audited Annual Accounts to MHRD in the absence of University Court as and when the Audit Report is received from CAG Delhi. However, the Audited Annual Accounts for the financial year 2015-16 shall be reported to the Executive Council in its next meeting.
