- 2. The Vice-Chancellor, CUHP (Chairman) extended a warm welcome and thanked all the members for sparing their valuable time to make it possible to attend this meeting. The Chairman also welcomed Prof. K.R.S. Smbhashiva Rao, Vice-Chancellor, University of Mizoram, Aizawl, Mizoram and introduced Prof. Rao among the members as he was attending the Executive Council meeting for the first time.
- 3. The Vice-Chancellor informed the members of the Executive Council that "National Geo Science Award-2017" has been conferred by President of India on 16 May, 2018 to Prof. Ambrish Kumar Mahajan, Dean, School of Life Sciences for his achievement in the field of Earth Applied Geophysics. The award carries cash award of Rs. 3,00,000 and a citation. Prof. O.S.K. Sastry, Department of Physics and Astronomical Sciences has been conferred "Best Teaching Innovator-2016" by Ministry of Human Resource Development under the Pandit Madan Mohan Malaviyya National Mission for Teachers Training Scheme. The award has a citation a Silver Medal and cash award of Rs. 75,000. The Executive Council noted and desired that an appreciation letter on behalf of the Executive Council be issued to Prof. Mahajan and Prof. Sastry for these awards.
- 4. Further, Prof. A.K. Mahajan apprised the members that the Central University of Himachal Pradesh has also installed two Earthquake recording units at Jia near Dharamshala and Nurpur in collaboration with Indian Institute of Remote Sensing, Dehradun. The Executive Council placed on record the appreciation for Prof. Ambrish Kumar Mahajan for his efforts to had collaboration with IIRS, Dehradun.

ITEM(S) FOR CONSIDERATION AND DECISION

Item No. 38.3 To place before the Executive Council the matter regarding amendment in Ordinance 7 dealing with Functions and Responsibilities of the Dean Students' Welfare (DSW).

The Statute 42 regarding Appointment of Dean of Students' Welfare as an Officer of the University was prepared by the University. After due assent from the Visitor of the University as conveyed vide MHRD letter No. F. 42-26/2009-Desk (U) dated 21.03.2011, the same was also

published in the Gazette of India on 10.08.2011 and was enacted in the University as such.

Statute 42(6) contains provision that functions, duties and responsibilities of a Dean of Students' Welfare shall be prescribed by the Ordinances. Accordingly, the University approved an Ordinance 7 regarding function and responsibilities of the Deans Students' Welfare which was silent about the emoluments, mode of appointments, terms and conditions of the services of the Dean Students' Welfare.

The said Ordinance 7 therefore, needs to be replaced with the detailed provisions regarding functions, duties and responsibilities, mode of appointment, emoluments, terms and conditions of services etc. of Dean Students' Welfare.

The amended Ordinance 7 for Functions, Responsibilities, Emoluments, Terms & Conditions of Services etc. of Dean Students' Welfare as per ANNEXURE-38.3 was considered and approved by the Executive Council.

Item No. 38.4

To place before the Executive Council the matter regarding confirmation of Prof. Ambrish Kumar Mahajan, Department of Environmental Science.

Dr. Ambrish Kumar Mahajan was appointed as Professor in the Department of Environment Science in the pay scale of Rs. 37400-67000 plus AGP Rs. 10000/-. He has joined this University on 26th February, 2013(F/N). As per terms and conditions of the appointment letter, the appointment of Professor was on probation for a period of one year in the first instance from the date of their joining which may further be extended for one year.

Dr. Ambrish Kumar Mahajan was relieved by Wadia Institute of Himalayan Geology, Dehradun vide letter No. 51/4-28/82-SSTH/WIHHG/1116 dated 22^{nd} February, 2013 by retaining lien on his permanent post initially for two years w.e.f. 23.02.2013 which was further extended by the parent department of the teacher from time to time.

Further, Prof. Ambrish Kumar Mahajan has tendered his technical resignation to his parent department on 26th November, 2018 (A/N). The Wadia Institute of Himalayan Geology, Dehradun has accepted his resignation from his parent post w.e.f. 26th November, 2018 (A/N) vide letter No. 51-28/82-S.S.T.H./W.I.H.H.G./ Vol.III/ 1654 dated 18.12.2018.

In view of above and provisions contained in Government of India's Order (1) below FR 14-A, Dr. Ambrish Kumar Mahajan is to be confirmed as Professor in Central University of Himachal Pradesh w.e.f. 26^{th} November, 2018 (A/N). The order of confirmation/ permanent absorption shall be issued from the date of acceptance of his resignation i.e. 26^{th} November, 2018 (A/N).

Accordingly, the work and conduct of the above teacher during his probation and lien period has been obtained from the Pro Vice-Chancellor who has recommended for clearance of probation of above teacher.

Dr. Ambrish Kumar Mahajan walked out during the course of discussion/deliberation on the instant item, being the matter of his personal concern.

The Executive Council confirmed the services of Dr. Ambrish Kumar Mahajan as Professor in Central University of Himachal Pradesh w.e.f. 26th November, 2018 (A/N).
