At the outset, the Vice-Chancellor, CUHP (Chairman) extended a warm welcome and thanked all the members for sparing their valuable time to make it possible to attend this meeting despite inclement weather conditions.

The Vice-Chancellor explained to the members that this is a **Special Meeting** of **Academic Council** which has been convened in connection with the **Fourth Annual Convocation** of the University. He informed that 358 students have completed their Certificate/ Advanced Diploma/ PG Degree / Ph.D. Degree in this University who are proposed to be conferred with Degrees / Advanced Diploma / Certificate during the Convocation.

THE AGENDA WAS THEN TAKEN UP FOR DISCUSSION:

Item No: 19.1

To ratify the action taken by the Vice-Chancellor under sub-section (3) of Section 11 of the Central Universities Act 2009 with regard to approval of University Prospectus 2017-18 for admission to Certificate/Under-Graduate/Post-Graduate Programmes.

In order to start the process of admissions to the approved Certificate/Under-Graduate/Post-Graduate Programmes, the prospectus of the University was drafted out by the committee consisting of all Deans of different Schools and Dean Students' Welfare, under the direction and supervision of the Vice-Chancellor. A copy of the University Prospectus 2017-18 is placed before the Academic Council at ANNEXURE – 19.1A.

As per Statute 14(d), the power to frame such regulations and rules consistent with the Statutes and the Ordinances regarding the academic functioning of the University, discipline, residence, admission, award of fellowship and studentships, fees, concessions, corporate life and attendance is vested with the Academic Council of the University. As such, the Prospectus of the University for the Academic Year 2017-18 for admission to Certificate/Under-Graduate/Post-Graduate Programmes was required to be considered and approved by the Academic Council.

Since the process of making admissions could not be started until the prospectus is approved by the competent authority i.e. Academic Council and it was not possible to convene the meeting of the Academic Council, in view of the fact that the admission process is an important and time bound activity, the Prospectus 2017-18 of the University was approved by the Vice-Chancellor, in exercise of the powers vested in him vide sub-section (3) of Section 11 of the Central Universities Act 2009, in anticipation of the approval of the Academic Council.

The Academic Council noted and ratified the decision taken by the Vice-Chancellor. Further, the Academic Council suggested that in future intake shown against Ph.D. programmes may not be given as there is change in intake according to the vacant seats in the Department.

Item No:19.2

To place before the Academic Council the matter regarding approval of the modified Format of Certificate Course, Advanced Diploma, PG Diploma and Ph.D. Degree

The Academic Council and the Executive Council approved the formats for the award of Degree, Merit Certificate and D.Phil., Honoris Causa in their 11th (Special) Meeting held on 11th February, 2014 respectively. After reviewing

the feedback received about the contents and their presentation in the Degree, certain minor modifications are required.

Accordingly, after carrying out these modifications, the modified format of Certificate, Advanced Diploma, PG Degree and Ph.D. are placed at ANNEXURE-19.2A, ANNEXURE - 19.2B, ANNEXURE - 19.2C and ANNEXURE - 19.2D respectively for approval.

The Academic Council approved and recommended the modified Format of Certificate, Advanced Diploma, PG Degree, and Ph.D to the Executive Council for approval. The Council also recommended that in future place and date of the Certificates/Degrees/ Diplomas be plced at the bottom.
