- 7. The admitted candidate must report in person to the Chairman of the Admission Committee of the Department on 01-08-2024, for registration and verification of academic qualifications/documents. He/She must bring the following documents:
  - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
    - i. Mark sheets of Matriculation and 10+2 and Graduation.
    - ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
    - iii. Kashmiri Migrant Certificate, if applicable.
    - iv. Persons with Disabilities Certificate, if applicable.
    - v. EWS Certificate, if applicable

- (b) Original Documents to be submitted:
  - i. Migration Certificate
  - ii. Character Certificate
  - iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
  - iv. Employer's no objection certificate, if applicable
  - v. Two Passport size photographs.
  - vi. Aadhaar Card Copy
  - vii. Fee receipt
- 8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
- 9. The registration for courses in a Programme of Study shall be made on 1<sup>st</sup> August, 2024. The regular classes shall commence from 1<sup>st</sup> August, 2024 tentatively. Any change in commencement of classes shall be intimated to all selected candidates through E-mail/University website.
- 10. In case the seats remain vacant, the **Second Selection** list will be displayed/uploaded on University Notice Board/Website on **22<sup>nd</sup> May**, **2024 after 5:00 PM**.
