- 7. The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on 01 August 2024 for registration and verification of academic qualifications/documents. He/she must bring the following documents:
 - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
 - i. Mark sheets of Matriculation, 10+2 and Graduation.
 - ii. Category Certificate, if applicable (OBC certificate should have not been issued later than six months).
 - iii. Kashmiri Migrant Certificate, if applicable.
 - iv. Persons with Disabilities Certificate, if applicable.
 - v. EWS Certificate, if applicable
 - vi. Aadhar Card

- (b) Original Documents to be submitted:
 - i. Migration Certificate
 - ii. Character Certificate
 - iii. Self-declaration by the student for intervening period/ over a gap of three years, if applicable
 - iv. Employer's no objection certificate, if applicable
 - v. Two Passport size photographs.
- 8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information/ qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
- 9. The registration for courses in a Programme of Study shall be made on **01** August **2024**. The regular classes shall commence from **02** August **2024** tentatively. Any change in the commencement of classes shall be intimated to all selected candidates through E-mail/University website.
- 10. If the seats remain vacant, the details will be uploaded on the University website. Interested candidates are advised to visit the University website/Notice Board regularly for updates.
