The **Provisional 2nd Selection list** of candidates selected for **admission** to **MA Economics** (Academic Session 2025-26) in the **Department of Economics**, School of Social Sciences, is enclosed herewith. This list has been prepared on the basis of merit in qualifying exams. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

1. "<u>The OBC candidates who belong to Non-Creamy layer and whose castes appear in</u> <u>Central list of the OBCs shall be eligible for admission under the OBC category</u>." If the Candidates selected in OBC category do not belong to Non Creamy layer they must not deposit the admission fee. As their admission will be cancelled at time of

verification of documents and registration.

- 2. The selected candidates have to **deposit** the admission fee latest by **27th June 2025** failing which the vacant seats shall be offered to the wait-listed candidates.
- 3. Total Fee for MA Economics: Rs. 5550.00
- 4. Option of Paying the Admission Fee shall remain open from 24th June to 27th June 2025.
- 5. Link to making payment for the admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study were opted.
- 6. Proof of Confirmation of fee submission received from SAMARTH Portal/payment gateway should be sent to the department Email ID: hod_eco@hpcu.ac.in latest by 11:00 am of 29 June 2025.
- 7. The admitted candidate must report in person to the Chairman of the Admission Committee of the concerned Department/School on **21 July 2025** for registration and verification of academic qualifications/documents. He/she must bring the following documents:
 - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
 - i. Mark sheets of Matriculation, 10+2 and Graduation.
 - ii. Category Certificate, if applicable (OBC certificate should have not been issued later than six months).
 - iii. Kashmiri Migrant Certificate, if applicable.
 - iv. Persons with Disabilities Certificate, if applicable.
 - v. EWS Certificate, if applicable
 - vi. Aadhar Card

- (b) Original Documents to be submitted:
 - i. Migration Certificate
 - ii. Character Certificate
 - iii. Self-declaration by the student for the intervening period/ over a gap of three years, if applicable
 - iv. Employer's no objection certificate, if applicable
 - v. Two Passport size photographs.
- 8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information/ qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her.
- 9. The registration for courses in a Programme of Study shall be done on **21 July 2025**. The regular classes shall commence from **21 July 2025** tentatively. Any change in the commencement of classes shall be intimated to the selected candidates through e-mail/University website.
- 10. In case the seats remain vacant, the 3rd Selection list will be displayed/uploaded on the University Notice Board/Website on **30 June 2025**.
