The Provisional Selection list of candidates selected for admission to **MA** (**Political Science**) for the Academic Session 2025-26 is enclosed herewith. This list has been prepared on the basis of merit in qualifying exams. Every care has been taken to prepare the selection list. Mistakes, if any, are inadvertent and subject to rectification.

- 1. "The OBC candidates who belong to non-creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category."
- If the Candidates selected in OBC category do not belong to non-creamy layer they must not deposit the admission fee. As their admission will be cancelled at time of verification of Documents and registration.
- 2. The selected candidates must deposit the admission fee latest by **01**st **August**, **2025** failing which the vacant seats shall be offered to the wait-listed candidates.
- 3. Total Fee for-

MA (Political Science) (Self-Financed): Rs.50, 000

- 4. Option of Paying the Admission Fee shall remain open from 29th July, 2025 till 01st August, 2025 till 05:00 pm
- 5. Link of making payment for the admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programme of Study was opted.(https://cuhimachaladm.samarth.edu.in/index.php/site/login)
- 6. Proof of Confirmation of fee submission received from SAMARTH Portal / payment gateway should be send to the department at email: hod_polsc@hpcu.ac.in Latest by 01st August, 2025.
- 7. The admitted candidate must report in person to the Chairman of the Admission Committee of the Department on **04-08-2025**, for registration and verification of academic qualifications/documents. He/ She must bring the following documents:
- (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
- i. Mark sheets of Matriculation and 10+2 and Graduation.
- ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
- iii. Kashmiri Migrant Certificate, if applicable.
- iv. Persons with Disabilities Certificate, if applicable.
- v. EWS Certificate, if applicable

(b) Original Documents to be submitted:

- i. Migration Certificate
- ii. Character Certificate
- iii. Self-declaration by student for intervening period/ over a gap of three years, if applicable
- iv. Employer's no objection certificate, if applicable
- v. Two Passport size photographs.
- vi. Aadhaar Card
- 8. The admission shall be strictly provisional subject to the verification of Academic qualifications and documents at the time of registration and shall be cancelled in case of submission of false information / qualifications by candidate. In that case the fees deposited by the candidate may not be refunded and the whole responsibility shall lie on him/her. NOTE:
 - In case the number of applicants for any Undergraduate Programme of study is less than 10, the University reserves the right to not making admissions to the respective programme for a particular session.
 - The intake capacity of the different programmes of study is only indicative and the university may reduce the intake depending on the availability of suitably qualified candidates, intellectual resources, Teacher/Faculty and other academic infrastructure.
- 9. The regular classes shall commence from **05-08-2025** tentatively. Any change in commencement of classes shall be intimated to all selected candidates through E-mail/University website.

Note: Admission to the M.A. Political Science programme is subject to the outcome of CWP No. 15106 of 2025, currently pending before the Hon'ble High Court of Punjab and Haryana. All admitted candidates are required to submit an undertaking in this regard. Failure to submit the undertaking after payment of fees will result in cancellation of the admission. The prescribed format for the undertaking is enclosed herewith.
