- 1. "The OBC candidates who belong to non-Creamy layer and whose castes appear in Central list of the OBCs shall be eligible for admission under the OBC category."
  - If the Candidates selected in **OBC** category do not belong to non-Creamy layer they must not deposit the admission fee else their admission will be cancelled at time of verification of documents and registration
- 2. The selected candidates have to deposit the admission fee latest by 13<sup>th</sup> August, 2025 (5.00 PM) failing which the vacant seats shall be offered to the wait-listed candidates.
- 3. Fee for Master of Commerce (M. Com) Self Finance Rs. 50000 (First Semester).
- 4. Option of Paying the Admission Fee shall remain open from 12<sup>th</sup> August 13<sup>th</sup> August, 2025 at 5:00 PM.
- 5. Link of making payment for the admission shall be available in the Dashboard of each Applicant. This Dashboard is the same from where Registration and specific Programmes of Study was opted.
- 6. The verification of the Documents of the admitted candidates will be done on 14<sup>th</sup> August, 2025 at Dhauladhar Parisar-II (in the premises of G.S.S. School (Boys), CUHP, Dharamshala, Kangra, HP, 176215 for registration and verification of academic qualifications/documents. He/she must provide the following documents:
  - (a) Original Documents to be shown to the Admission Committee and one self-attested copy of each document to be submitted:
    - i. Mark sheets of Matriculation and 10+2 and Graduation.
    - ii. Category Certificate if applicable (OBC certificate should have not been issued later than six months).
    - iii. Kashmiri Migrant Certificate, if applicable.

- iv. Persons with Disabilities Certificate, if applicable.
- v. EWS Certificate, if applicable
- vi. Employer's no-objection certificate, if applicable
- vii. Two passport-size photographs
- viii. Aadhaar Card
- 7. The admission shall be strictly provisional, subject to the verification of Academic qualifications and documents at the time of registration. It shall be cancelled in case of submission of false information / qualifications by the candidate. In that case, the fees deposited by the candidate may not be refunded, and the whole responsibility shall lie on him/her.
- 8. The registration for courses in a Programme of Study shall be made after document verification, and the same will be intimated to all selected candidates through Email/the University website.
