- (1) Consideration of the Draft of syllabus for Ph.D course work and its approval.
- (2) Consideration of the Draft of the syllabus for M.A History, Semester 1 IV and its approval by the Board of Studies.
- (3) Any other item to be raised with the Permission of the Chair.
- The meeting started with formal welcome of all the members by Chairman of the BOS, Head of Department and Dean, School of Social Sciences Prof. Narayan Singh Rao. Prof. Narayan Singh Rao welcomed all the members and gave their brief introduction to all the members.
- 1. The members subsequently took up the agenda item no.1. Dr. Kanwar Chanderdeep Singh presented the draft of the syllabus for PH.D course work. All the members expressed their views on the proposed draft of the syllabus. 
