

1. The University had advertised the above teaching posts vide Employment Notice No. 003/2024 dated 24.12.2024.
2. The University received numerous applications for the said posts and these applications were screened by the duly constituted Screening Committee(s). The Screening Committee(s) checked and verified the records of each applicant uploaded by them on CU Chayan Portal and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Employment Notice No. 003/2024 dated 24.12.2024.
3. After the screening, the University uploaded the status of applications of above subjects/disciplines on the University Website and the applicants were advised to go through their details carefully and submit discrepancy/objections/representation, if any, to the University.

4. Objections/Observations so received from the applicants were again placed before the said screening committee(s) and the final recommendation(s) of the screening committee(s) after examining the observations/representations raised by the applicant are attached at '**Annexure-1**'. Accordingly, **the final list of candidates provisionally shortlisted for Personal Interview** as per university rules is attached at '**Annexure-2**'
5. The University further decided that in view of the large number of applications for the positions of Assistant Professors in each discipline, the number of candidates to be called for interview against one vacancy be restricted to a maximum of 30. Further, in case of tie (i.e. more than one applicants having the same combined score all applicants having the same combined score as the 30th candidate in the discipline be short-listed to be called for interview. In case of each subsequent teaching post (of same cadre, same subject and same category), additional fifteen candidates be called for interview. The status of cut-off score in case of **(1) Assistant Professor in Department of Social Work, (2) Assistant Professor in Department of English & (3) Assistant Professor in Department of Journalism and Mass Communication** is placed at '**Annexure-3**'.
6. **The list of candidates who have been provisionally shortlisted for Personal Interview for various teaching positions (Phase-2) is hereby uploaded today on university website.**
7. The eligibility of the candidates is Provisional and the candidate(s) Shortlisted for interview has to substantiate his/her claims, as uploaded by him/her on the CU Chayan Portal and submitted with their representation if any, with the original documents before Interview in front of the document verification committee constituted by the University. The candidate(s) should ensure that they possess the eligibility as per UGC Regulations 2018 (As amended time to time).
