- 1. The University had advertised the above post vide Employment Notice No. 001/2024 dated 04.04.2025.
- 2. The University received numerous applications for the said post and these applications were screened by the duly constituted Screening Committee. The Screening Committee checked and verified the records of each applicant uploaded by them on the Portal and determined their eligibility strictly in accordance with the minimum qualification prescribed by the University vide Employment Notice No. 001/2025 dated 04.04.2025.
- 3. After the screening, the University uploaded the status of applications on the University Website and the applicants were advised to go through their details carefully and submit discrepancy/objections/representation, if any, to the University.
- 4. Objections/Observations so received from the applicants were again placed before the said screening committee and the final recommendations of the screening committee after examining the observations/representations raised by the applicant are attached at 'Annexure-1'. Accordingly, the final list of candidates provisionally shortlisted for Personal Interview as per university rules is attached at 'Annexure-2'
- 5. The list of candidates who have been provisionally shortlisted for Personal Interview for the post of Finance Officer is hereby uploaded today on university website.
- 6. The eligibility of the candidates is Provisional and the candidate(s) Shortlisted for interview has to substantiate his/her claims, as uploaded by him/her on the Portal and submitted with their representation if any, with the original documents before Interview in front of the document verification committee constituted by the University. The candidate(s) should ensure that they possess the eligibility as per Employment Notice No. 001/2025 dated 04.04.2025.
- 7. The Personal Interview for the post of Finance Officer will be held on 21.05.2025 at 09:00AM onwards in the Vice-Chancellor Secretariat, Central University of Himachal Pradesh, Dharamshala, District Kangra (HP)-176215.
