The Central University of Himachal Pradesh has entered into an agreement with CDSL Ventures Limited, Mumbai (Digital Depository authorized by the Ministry of Human Resource Development) for lodging its academic awards in National Academic Depository (NAD) on 22.04.2017. The CDSL Ventures Limited vide email dated 5th February, 2018 has requested the University to intimate the charges for verification of Degree/Certificates conferred by Central University of Himachal Pradesh.

The University has also received various requests for verification of Degree/Certificate from India & abroad from the employers/Head of the Institutes, Embassy or High Commission and Indian Credentials Verification Agencies. In view of the above, the Vice-Chancellor constituted a Committee vide Notification No. 7-1/CUHP/GA/2015/ 5044-47 dated 05.10.2028

to propose a fee structure for the verification of Degree/Certificates conferred by the University. The Chairman of the Committee submitted the report vide Letter F.No. PVC/1-1/CUHP/2018/1802 dated 11.10.2018 [ANNEXURE-27.1(T)]. The recommendations of the Committee are as under:-

- 1. The request of the verification of Degree/Certificates conferred by CUHP shall be done on the basis of formal request made by the concerned office on a prescribed pro-forma developed by the University.
- 2. The request for Degree/Certificate verification should be addressed to the office of the Controller of Examinations, CUHP.
- 3. The fee for the verification of Degree/Certificate shall be as follow:
 - a. INR 1500 per degree certification for verification request from India.
 - b. INR 5000 per degree certificate for verification request from abroad.
- 4. The fee for verification of Degree/Certificate is to be remitted through NEFT, NET Banking, Debit Card to the Finance Officer on the account details given in the Pro-forma.

The Academic Council deliberated on the recommendations submitted by the Chairman and unanimously approved the fee for the verification of Degree/Certificate as follow:

- (i). INR 1500 per degree certification for verification request from India.
- (ii). INR 10,000 per degree certification for verification request from abroad.

The Academic Council also approved the proforma for formal request for verification of Degree/Certificate.

- 3. हिमाचल प्रदेश केन्द्रीय विश्वविद्यालय का इतिहास विभाग प्रति वर्ष या दो वर्ष के अन्तराल के बाद हिमालयी इतिहास कांग्रेस का आयोजन किया करेगा।
- 4. आयोजन हेतु समाज विज्ञान स्कूल के अधिष्ठाता कांग्रेस के संरक्षक रहेंगे और इतिहास विभाग के विभागाध्यक्ष संयोजक तथा अध्यापक आयोजक सदस्य रहेंगे।

The Academic Council considered the proposal and approved the constitution of हिमालयी इतिहास परिषद and also approved Membership Format and further recommended to the Executive Council for its approval.

The Chairman apprised the members that University has appointed newly faculty in different departments. As per the condition of the appointment letter these teachers were on probation for a period of one year from the date of their joining in this University. For confirmation in the University a work and conduct report of the teacher is necessary. Therefore, to report the work and conduct, a channel could be prescribed. So the Academic Council members unanimously approved the following hierarchy:

For Dean: Pro-Vice-Chancellor, if not then Vice-Chancellor

For Head: Dean

For Professor/Associate Professor & Assistant Professor: Head
